### NOTABLE REPRESENTATIONS

- **In re Gour dough's Holdings, LLC et. al. (20-10720-hcm) (Bankr. W.D. Tex.).** Represent the affiliated Debtors in subchapter v case successfully resolving aggressive judgment creditor and landlord issues-on path towards confirmation.
- **In re Briseno, 571 B.R. 214, (Bankr. S.D. Tex. 2017).** Sought and obtained the appointment of a Chapter 11 Trustee due to mismanagement in a home construction case.
